How To Get Forms 1099, 1096, 1098, 5498, W-2G, and Instructions

Caution: Because the IRS processes paper forms by machine (optical character recognition equipment), you cannot file with the IRS Forms 1096, 1098, 1099, or 5498 that you print from the IRS Web Site.

- By phone. Call 1-800-TAX-FORM (1-800-829-3676).
- By personal computer. See Quick and Easy Access to Tax Help and Forms.

• By order blank. Complete Form 7018-C in this package or order online (see page 2 of Form 7018-C).

A number of commercial office product stores offer computer-printed versions of IRS forms for a small fee. Check your local telephone directory for sources.

How To File Forms 1098, 1099, 5498, and W-2G Electronically

You can now file Forms 1098, 1099, 5498, and W-2G electronically through the Filing Information Returns Electronically (FIRE) system. For information concerning the FIRE system, go to www.irs.gov/elec_svs/fire-sys.html. Also, you can now file most of these forms online through the approved IRS e-file for Business Providers. Go to www.irs.gov/elec_svs/abp.html to choose a vendor that offers online filing.

Electronic submission of Form 7018-C can now be made from the IRS Digital Daily web site at www.irs.gov/bus_info/index.html. Each item listed on this online order blank will have a maximum quantity of 1000 forms and 25 instructions that can be ordered. If you require a greater quantity than the maximum allowed, fill out the paper Form 7018-C and mail it to the appropriate Distribution Center.

Paperwork Reduction Act Notice. We ask for the information on this form to carry out the Internal Revenue laws of the United States. Your response is voluntary.

You are not required to provide the information requested on a form that is subject to the Paperwork Reduction Act unless the form displays a valid OMB control number.
